Disarmament for Development programme

In 2005 IPB launched a major new programme, designed to reflect widespread public concern at the rapid rise in global military spending (totalling \$1339 billion in 2007); and the evidence that weapons -- such as small arms, cluster bombs, landmines -- seriously impede sustainable development. Post 9-11, the failure of military solutions should be obvious to all. IPB advocates reductions in defence budgets and the adoption of a 'human security' approach. Activities organised in pursuit of these goals include: seminars, publications, website, e-newsletter, exhibitions and a short film. National and international networks are gradually being developed.

IPB Secretary General visits partners in the UK, France and Norway

Over the past few weeks Secretary General Colin Archer has travelled to meet various partners in the peace and disarmament movement. Some of the highlights included a two-day conference in Oslo, Norway with the European Network Against Arms Trade. The event was organized by our IPB Council member Alexander Harang. The bulk of the meeting was focused on country reports on arms trade but there was also a special focus on the famous Norwegian Pension Fund and the ethical criteria used to determine its investments - including weapons. He was also able to give a short presentation of the disarmament for development campaign. Annan announces that Africa faces \$40 billion aid shortfall

Former UN Secretary General Kofi Annan recently announced that the promise made by the G-8 to double aid to Africa by 2010 is far from being fulfilled. The current rate of increase will still fall short of meeting this goal by some \$40 billion. Yet the report, written by the panel set up to monitor progress towards the Africa Commission's goals, failed to name which

industrialized countries were not coming up with the money, the BBC's Africa analyst Martin Plaut says. Mr. Annan also called on Africa to keep its promise to improve governance on the continent, particularly in Zimbabwe and Sudan. He highlighted how important good governance will be in light of the global food crisis, which threatens to destabilize Africa's most vulnerable nations. Click here for full article

Military + social spending

International Peace Bureau deplores rise in global military spending

As world leaders scramble to find money to stabilize oil and food prices, mitigate climate change and address mass poverty, new figures show once again that military spending remains an 'untouchable' resource.

The Stockholm International Peace Research Institute (SIPRI) announced on 9 June, at the launch of its annual SIPRI Yearbook, that the figure for global military spending in 2007 reached a new high of **\$1,339 billion**, a rise of 6% over the previous 12 months. Of this amount, the USA spent \$547 billion (not counting the specific costs of the wars in Iraq and Afghanistan), which is its highest total in real terms since 1945 and represents over 40% of the global total. The next largest spenders were the UK (\$59.7bn), China (\$58.3bn) and France (\$53.6bn). For details of the SIPRI Yearbook, go to: www.sipri.org, and for IPB's full statement please click here.

Swedish pension fund AP7 sells all holdings in companies making cluster bombs

The Swedish pension fund AP7 Sunday said it will sell all its holdings in companies making cluster bombs and nuclear weapons, including Airbus parent EADS and U.S.-based Lockheed Martin Corp. and General Dynamics Corp. He said the value of the holdings was not big but the decision should be seen as an appeal to other fund managers to reconsider their investments in such companies. More than 100 countries adopt treaty banning cluster bombs

On 30 May, a major victory for humanity was achieved with the adoption of a new Cluster Munitions Convention, at the Dublin Diplomatic <u>Conference on</u> <u>Cluster Munitions</u>. "After ten days of intense negotiation under Irish leadership, 110 countries negotiating at the conference and hundreds of campaigners and survivors within the Cluster Munitions Coalition welcomed the treaty." (Cluster Munitions Coalition) The comprehensive treaty bans the use, production, trade and stockpiling of cluster bombs. To keep pressure on governments and to ensure that the treaty enters into force, campaigners launched the People's Treaty. Sign it now! Nobel Laureate Jody Williams was in Dublin throughout the treaty negotiations. She was joined by Nobel Laureates Mairead Corrigan Maguire and Betty Williams for a public event. 'Special Weapons' have a fallout on babies

Babies born in Fallujah are showing illnesses and deformities on a scale never seen before, doctors and residents say. The new cases, and the number of deaths among children, have risen after "special weaponry" was used in the two massive bombing campaigns in Fallujah in 2004. After denying it at first, the Pentagon admitted in November 2005 that white phosphorous, a restricted incendiary weapon, was used a year earlier in Fallujah. In addition, depleted uranium (DU) munitions, which contain lowlevel radioactive waste, were used heavily in Fallujah. Full article at http://www.commondreams.org

Study backs nuclear test veterans' claims

Nuclear-test veterans say the Government must finally "*stop sitting on its hands*" now international experts have upheld Massey University research exposing the extent of the genetic damage they suffered. Associate Professor AI Rowland's world-first study - which showed naval veterans who were exposed to nuclear tests in the Pacific 50 years ago had 300 per cent more genetic mutations than normal - has just been published in the prestigious journal Cytogenetic and Genome Research. Australia establishes a new disarmament and non-proliferation commission

On 9 June, Australian Prime Minister Kevin Rudd announced the establishment of the International Nuclear Non-Proliferation and Disarmament Commission, which he hopes will coordinate international talks ahead of the nuclear Non-Proliferation Treaty Review Conference in 2010. He has appointed former foreign affairs minister Gareth Evans to be head of the commission. A Japanese official will reportedly co-chair the body. Full article at http://afp.google.com

In defense policy, France turns to U.S. and Europe

In its first new national defense policy in 14 years, France has decided that its security lies within Europe and NATO, establishing a significant shift from the country's longstanding notions of moral and military self-sufficiency. More than four decades ago, Charles de Gaulle, angry with American and British domination of the North Atlantic Treaty Organization, said France's military integration into the alliance had been *"stripped of justification."* But now that the Soviet Union is gone and the European Union is more fully established, President Nicolas Sarkozy has decided that France is best served by participating fully with Washington and NATO, in part because the vast majority of members of the European Union are also members of the alliance. Participants from ten countries met at the international Afghanistan-Congress in Hannover to discuss 60th NATO anniversary in May 2009, which will be celebrated with an official summit in Strasbourg and Kehl. A conference to discuss international protest and action against NATO's celebration will be held in France or Germany, most likely in October 2008 and all interested groups are invited to attend.
