### Disarmament for Development Programme

In 2005 IPB launched a major new programme, designed to reflect widespread public concern at the rapid rise in global military spending (now totalling \$1118 billion); and the evidence that weapons -- such as small arms, cluster bombs, landmines -- seriously impede sustainable development. Post 9-11, the failure of military solutions should be obvious to all. IPB advocates reductions in defence budgets and the adoption of a 'human security' approach. Activities organised in pursuit of these goals include: seminars, publications, website, e-newsletter, exhibitions and a short film. National and international networks are gradually being developed.

### Oslo conference calls for a new treaty on cluster munitions

Following years of work by NGOs such as the Cluster Munitions Coalition, a meeting was held in Oslo from 21-24 February. Forty governments reached a commitment to negotiate and conclude a new treaty to ban cluster munitions by 2008. The Oslo conference hopefully sets a new international framework for rejecting the use of cluster munitions and dealing with their devastating effects.

### Increase in Swiss arms exports

The organization (GSsA) lobbying for Swiss without an Army is stunned the sharp increase in Swiss arms exports for 2006. Statistics published by the Swiss Federal Customs administration show a 1/3 increase in Swiss arms export compared to 2005. Last year most of the arms were exported to Saudi Arabia, India and Egypt. GSsA is collecting signatures from militants that will enable them pass a bill to stop Swiss Arms exports. So far, 75'000 signatures have been collected.

It serves as a reminder to governments of the necessity to fully commit to the Mine Ban Treaty of 1997.

#### Banks funding cluster munitions producers

68 financial institutions have been found to play a role in financing companies producing Cluster Munitions. Netwerk Vlaanderen has launched its new briefing paper called <u>'Explosive Investments'</u> revealing the results of its research into the financing of six companies producing Cluster Munitions. Together the six Cluster Munitions companies secured credit facilities amounting to US\$ 12.6 billion (€ 10 billion) during 2004-2007.

### International meeting on nuclear weapons and terrorism

Meeting in Turkey on 12 February, representatives from the G-8 countries alongside China, Turkey, Kazakhstan, Morocco and Australia discussed guidelines for keeping track of radioactive materials and for ensuring the safety of nuclear facilities. They also pledged to combat the illicit trafficking of nuclear materials.

# Japan submit a nuclear terrorism Bill to parliament

The Japanese government has submitted a new nuclear terrorism bill to parliament. If passed, the legislation will penalize the deliberate release of radiation and those who own radioactive substances or manufacture equipment that produces such substances for terrorism purposes. By ratifying this Bill, Japan hopes to promote the international convention adopted by the UN General Assembly in 2005 but failed to take effect due to shortage of signatories.

### US and International stance on Iran's nuclear programme criticised

The precondition of the US and Europe that Iran freeze its nuclear enrichment as a prerequisite for negotiation is severely criticised by Hans Blix and Richard Haass President of US Council on Foreign Relations. According to Hans Blix, Europe and UN Security Council are « humiliating » Iran in setting out such preconditions. "This is in a way like telling a child, first you will behave and thereafter you will be given your rewards," Blix said. "And this, I think, is humiliating." Many experts think that imposing preconditions on Iran is blocking diplomatic progress to deal with the Iranian nuclear crisis.

#### The International Criminal Court to prosecute war criminals in Sudan

The International Criminal Court (ICC) named suspects last Tuesday to be prosecuted for war crimes committed in Sudan. The Sudanese Humanitarian Affairs Minister Ahmed Haroun and Janjaweed militia leader Ali Muhammad Ali Abd al-Rahman were among those to be prosecuted by the ICC. About 200,000 people have died and more than two million people have fled their homes during the four-year conflict.
